



## **Documents to Bring to the Consulate General of France in New York**

## **Lang in Paris**

- ✓ Copy of your acceptance letter from The New School
- √ From your Campus France mailbox:
  - o Copy of the confirmation email, which starts with "Your Campus France file has been processed."
  - Copy of the proof of payment email (PDF entitled "Une Quittance est disponible" attached to email)
- ✓ Passport in good condition, with a date of expiration at least 3 months after the end of the your proposed stay in the Schengen area, issued within the past 10 years and containing at least 2 blank pages
  - AND Photocopy of the pages containing the passport holder's personal data
- ✓ 1 recent photograph in U.S. passport photo format
- ✓ Application Form

- ✓ Fee (cash in US dollars, VISA, MasterCard)

- Proof of Sufficient Means of Support (ORIGINAL + 1 PHOTOCOPY)
  - o Non-scholarship students must prove access to at least \$820 per month, provided in the form of:
    - A bank statement showing a balance of \$820 multiplied by the number of months in France
    - OR a notarized statement from a guarantor declaring that the guarantor will provide the student with at least \$820 per month, accompanied by the guarantor's most recent bank statement
  - Scholarship and financial aid students should include:
    - Letter of scholarship award specifying amount and duration of award, issued by the Financial Aid Office for The New School
    - Visa Services at the Consulate also needs a specific breakdown of your available financial resources (remaining aid) once the tuition fees have been paid for
- ✓ Airline Ticket or Reservation
  - O An airline reservation showing date of departure <u>OR</u> a handwritten and legible statement indicating your intended date of departure, as well as a formal commitment not to depart before that date NB: It is not possible to modify the validity starting date of a visa once the application is made
- Proof of Residence in New York, New Jersey, Connecticut, or Bermuda (ORIGINAL + 1 PHOTOCOPY)
  - Lease or rental agreement in your name, or a notarized statement from the owner or leaseholder plus a recent (utility) bill in your name
  - o **OR** your driver's license issued from New York, New Jersey, Connecticut, or Bermuda.
  - OR a valid student ID card (or a statement issued within the past 2 months by the registrar's office of The New School)
- ✓ OFII Form

## **Only Required If**

- You will be staying in France for more than 6 months (180 days)
- You wish to be allowed to work in France while studying
- You wish to be able to extend your visa once in France
